Dues payments to Barrow County Builders Association are not deductible as charitable contributions for federal income tax purposes. However, dues payments may be deductible as ordinary and necessary business expense, subject to exclusion for lobbying activity. Because a portion of your dues is used for lobbying by NAHB, 16% of the NAHB dues, or \$24.00 is not deductible for income tax purposes. Fifty percent, which amounts to \$50, is the estimated amount of your HBAG dues for lobbying. So the total amount that IS deductible as ordinary and necessary business expense is \$301.00.
